CALL TO ORDER - GSA MEETING.

1. <u>PUBLIC COMMENT – GSA MATTERS</u>. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the Groundwater Sustainability Agency ("District GSA"). Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.

2. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes of the Board's February 8, 2023 board meeting.

3. <u>BASIN COORDINATION</u>. The Board will hear a report from the District GSA's representatives regarding the status of the coordination of activities among the GSAs in the Madera Subbasin. General counsel and/or Director Janzen may report to the Board regarding any recent basin meetings and the status of the revisions to the Joint GSP as a result of the Department of Water Resources' incomplete determination of that Joint GSP. General counsel will report to the Board regarding DWR's rejection of the Chowchilla subbasin revised GSP. The Board may take action to advise the District's GSA representatives on positions to be taken by the District in connection with the Joint GSP.

4. <u>MADERA LAKE PROJECT</u>. The Board may hear a report by the District's consultants regarding the status of the Madera Lake project and the State grant obtained by the District for the planning and construction of the Madera Lake Project. The Board may take action in connection with the Madera Lake Pump and Pipeline Project approved by the District board of directors.

5. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.

ADJOURNMENT.

Written materials related to an agenda item to be considered in open session that are public records will be made available for public inspection upon request.
