#### CALL TO ORDER - GSA MEETING.

- 1. <u>PUBLIC COMMENT GSA MATTERS</u>. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. The Board may hear a report from legal counsel regarding estimates to hire a land appraiser from Xavier Correia in connection with obtaining an appraisal of land within the District GSA. The Board may review and take action to approve a contract to retain Xavier Correia for appraisal services. The Board may further authorize District GSA officers and consultants to take such further actions as necessary to move forward with retaining appraisal services from Xavier Correia.
- 5. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.
