CALL TO ORDER – GSA MEETING.

1. PUBLIC COMMENT – GSA MATTERS. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the Groundwater Sustainability Agency (“District GSA”). Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.

2. APPROVAL OF REMOTE MEETING. The Board will discuss the need for a remote meeting and may pass a resolution allowing such a remote meeting.

3. APPROVAL OF MINUTES. The Board may review and approve the minutes of the August 10, 2022 GSA meeting.

4. BASIN COORDINATION. The Board may hear a report from the District GSA's representatives regarding the status of the coordination of activities among the GSAs in the Madera Subbasin. General counsel will discuss the "incomplete" determination made by DWR for the Madera subbasin and the impact of that determination on the District's GSP and the other GSPs covering the subbasin. General counsel and/or Director Janzen will report to the Board regarding any recent basin meetings and the status of the proposed domestic well mitigation program being developed for the basin.

5. MADERA LAKE PROJECT. The Board will hear a report by the District's consultants regarding the status of the Madera Lake project and the State grant obtained by the District for the planning and construction of the Madera Lake Project. In connection with the State grant, The Board may authorize District GSA officers to execute an agreement with Root Creek Water District in connection with the Madera Lake Project grant funding and may also authorize consultants to take such further actions as necessary in connection with the Madera Lake Project or the receipt of grant funds from the State.

6. DIRECTOR COMMENTS. The Board may discuss other items as permitted by the California Government Code.

ADJOURNMENT.

Written materials related to an agenda item to be considered in open session that are public records will be made available for public inspection upon request.
