## CALL TO ORDER – GROUNDWATER SUSTAINABILITY AGENCY ("GSA") MEETING.

- 1. <u>PUBLIC COMMENT GSA MATTERS</u>. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the GSA. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.
- 2. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes of the July 10, 2019 meeting of the Board.
- 3. <u>FINANCIAL MATTERS</u>. The Board may review, discuss and possibly approve bills to be paid by the GSA and/or ratify prior payment of bills. The Board may also review, discuss and possibly approve other financial matters related to GSA activities.
- 4. <u>GROUNDWATER COORDINATION COMMITTEE</u>. The Board may hear a report from its representatives on the Madera Subbasin Coordination Committee regarding groundwater sustainability plan ("GSP") developments and updates from Committee workshop meetings. The Board may take action to direct the GSA's consultants regarding matters related to the development of the GSP including scheduling a workshop to discuss draft GSP chapters with interested parties.
- 5. <u>IRWM PLAN UPDATE</u>. The Board may review, discuss and possibly approve an updated version of the Madera Integrated Regional Water Management Plan.
- 6. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.

## ADJOURNMENT.
