The Board will hear a report from the District GSA representative regarding the status of the submission of the revised Joint GSP to DWR, and coordination among the subbasin GSAs. The Board may take action to advise the District's GSA representatives on positions to be taken by the District in connection with the Joint GSP and/or other basin activities or programs impacting the District.
- 4. <u>MADERA LAKE PROJECT</u>. The Board may hear a report by the District's consultants regarding the status of the Madera Lake Project and the State grant obtained by the District for the planning and construction of the Madera Lake Project. The Board may consider and take action in connection with the Madera Lake Pump and Pipeline Project approved by the District board of directors, and/or any easement necessary for the project.
- 5. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.
