The Board may hear a report by the District's consultants regarding the status of the Madera Lake Project and the State grant obtained by the District for the planning and construction of the Madera Lake Project. The Board may consider and take action in connection with the Madera Lake Pump and Pipeline Project approved by the District board of directors, and/or any easements necessary for the project.
