**CALL TO ORDER – GSA MEETING.**

1. PUBLIC COMMENT – GSA MATTERS. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the Groundwater Sustainability Agency (“District GSA”). Speakers shall be limited to three minutes. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.
  
2. APPROVAL OF MINUTES. The Board may review and approve the minutes of the Board’s July 10, 2024 board meeting. **Action Item.**
  
3. BASIN COORDINATION. The Board will hear a report from the District GSA representative regarding the status of the submission of the revised Joint GSP to DWR, and coordination among the subbasin GSAs. The Board will also discuss the annual and five-year update efforts and process for the GSP. The Board may take action to advise the District’s GSA representatives on positions to be taken by the District in connection with the Joint GSP and/or other basin activities or programs impacting the District. **Action Item.**
  
4. MADERA LAKE PROJECT AND EASEMENT. The Board may hear a report by the District’s consultants regarding the status of the Madera Lake Project and the State grant obtained by the District for the planning and construction of the Madera Lake Project. **Discussion and Action.**
  
5. EASEMENT WITH SUNNYSIDE AVENUE MADERA, LP FOR MADERA LAKE PROJECT. The Board will consider and take action to execute the Final Easement provided by Sunnyside Avenue Madera, LP (landowner). The Board will authorize signors for such easement. **Action Item.**
  
6. DIRECTOR COMMENTS. The Board may discuss other items as permitted by the California Government Code.
